## GOVERNMENT MEDICAL COLLEGE - Nalgonda TERMS & CONDITIONS FOR CANTEEN TENDER NOTIFICATION

- Willing bidder should submit EMD of Rs. 10,000/- in the form of Demand
  Draft in favour of "College Development Society, GMC, Nalgonda" with
  application to participate in the tender. In case of unsuccessful bidder the
  EMD paid by them is refundable.
- 2. The bidder should enclose the following certificates at the time of submission of bid.
  - Trade licence
  - Labour licence
  - Food Safety licence
  - ❖ GST certificate
  - Sales Tax certificate
  - Experience certificate in canteen running. Minimum (2) years and above Preferable.
- 3. The Period for the Contract will be for two years renewable for the period of (1) year based on performance with an escalation of 10% hike in the rent 3<sup>rd</sup> year.
- 4. Suitable accommodation will be provided for canteen and will not be issued for any purpose, than the bonafide once.
- 5. The kitchenware, cookware, tables, chairs, fixtures & fittings / installation of cabin etc will have to be borne by the tenderer and it should be of good quality.
- 6. The tender will have to make his own arrangements for usable and labourers etc.
- 7. The timing of the canteen will be from 7.00 AM to 7.00 PM.
- 8. No alteration or additions will be permissible, any such attempt will be subject to removal / termination without any notice.
- 9. The minimum bid (Rent) for canteen will start from Rs. 10,000/- per month.
- 10. The successful bidder will have to deposit Rs. 2,00,000/- (Rupees Two lakhs only) towards refundable advance.
- 11. On notice he should vacate the premises within a period of one month or incase of discontinuation he should inform before one month to college authorities.
- 12. No obscene photographs be exhibited in the canteen.
- 13. Should behave politely with the staff and students.
- 14. Quality to be maintained as per standards liable to be inspected by the Principal, GMC, Nalgonda, Food Safety Officer and any other authorities.

The rates and items in the canteen will be fixed by the mutual understanding of Canteen committee Govt. Medical College, Nalgonda & Tenderer.

- 15. No other business will be allowed.
- 16. Cigarettes, Liquor, Pan etc will not be allowed.
- 17. The canteen will not be subleased by the allottee to any other person.
- 18. The firm owner should install sub-meter in the name of canteen, GMC, Nalgonda and pay electricity charges.
- 19. Staff of this college are not allowed to participate in the tender.
- 20. The canteen and its surroundings, furniture, crockery and utensils etc should be maintained cleanly.
- 21. The Successful bidder should start operating the canteen immediately.
- 22. The successful bidder will have to execute a bond of arrangement on Non judicial stamp paper of Rs. 100/- with surety that he will abide by the terms and conditions and will be responsible for any unlawful activity.
- 23. In case of violation of rules, terms and conditions of the agreement or any misconduct of the canteen holders of his staff causing any nuisance or any other involvement of unlawful activities, the Principal, Government Medical College, Nalgonda will have the right to terminate the contract and close the canteen, duly serving one month notice to vacate the premises the EMD will be confiscated and will have the right to run the canteen duly re-auctioned.
- 24. The Head of Institutions will not take any responsibility to collect or recover the amount due from the employees and students and the contractor should enforce cash down system.
- 25. The Head of institutions will not take any responsibility for the liability incurred by the Contractor / bidder.
- 26. The Head of institutions shall have to amend the rules and enforce the same from time to time if necessary and accordance with the rules.
