2. Accordingly your application was processed u/s 10A of the IMC Act, 1956 and Establishment of New Medical Colleges Regulations, 1999. I am directed to convey the permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal of permission for admission of 2nd batch of 150 (one hundred and fifty) MBBS students of Government of Medical College, Nalgonda, Telangana u/s 28 read with section 61(2) of NMC Act, 2019 for the academic year 2020-21.
